

Application for Participation In The Randolph County Voluntary Agricultural District Program

APPLICATION PROCEDURE

Requirements for Enrollment:

To qualify as farmland eligible for this program, it must be real property that:

- Is engaged in agriculture as defined in N. C. General Statute 106-581.1.
- Meets the size requirements applicable to its class of use as set out in NC General Statute 105-277.3(a) and which therefore requires at least: 5 acres of horticultural land, 10 acres of agricultural land, or 20 acres of forestry that are in actual production.
- Be managed in acceptable soil and farming practices.
- Is managed, if highly erodible land exists on the farm, in accordance with the Natural Resources Conservation Service-defined erosion control practices that are addressed to highly erodible land.
- Be involved in direct agricultural or forestry production in accordance with NC General Statutes.
- Is the subject of a conservation agreement, as defined in N.C.G.S. 121-35, between the county and the owner of such land that prohibits non-farming use or development of such land for a period of at least ten years, except for the creation on not more than three lots that meet applicable zoning and subdivision regulations. This conservation agreement will become null and void if the land is removed from the Voluntary Agricultural District Program.

Steps in Application Procedure:

1. Receive application from NC Cooperative Extension office, 112 West Walker Ave., Asheboro, NC 27203 (336) 318-6000.
2. Obtain Conservation plan and signature of a Conservationist in the Soil and Water Department certifying that a conservation plan is in place for the property or properties. If no conservation plan has been developed for the property, consult with the conservationist and obtain the appropriate plan.
3. If your property has 20 or more acres in forest/timber, obtain a signature from the North Carolina Forest Service Randolph County Ranger to certify that you have a forest management plan.
4. Preference is given to property listed in the county farm present-use-value taxation program. However, land in agricultural use and meets the qualifications of General Statute 105-377.3 may be included upon review. If it is not designated in present use value taxation, a formal review as well as a possible site visit conducted by the members of the Voluntary Agricultural District Board may be required to determine eligibility for participation in the program.
5. The completed application with all required signatures should be returned to NC Cooperative Extension Office. NC Cooperative Extension, 112 West Walker Ave., Asheboro, NC 27203. For questions call, (336) 318-6000, (336) 819-3000 Archdale, (336) 218-4000 Liberty. Application will be given final approval or denial by the Agricultural Advisory Board and County Board of Commissioners. The Voluntary Agricultural District Board typically meets on

- the second Tuesday night at 7:00 in January, March, May, July, September, and November. Applications that have completed signatures and meet eligibility requirements are voted on at the Board meetings.
6. If approved, applicant will be notified to sign the Conservation Agreement and Notice of Participation. (See below)
 7. After the documents are signed, information will be forwarded to the Planning Department for mapping and recording of the new Voluntary Agricultural District farm. At least one Agricultural District sign will then be posted within six months of approval dependent on the Randolph County Maintenance Department's schedule.

CONSERVATION AGREEMENT

Having been certified by the Agricultural Advisory Board and approved by the Randolph County Board of Commissioners, I/we agree to sustain, promote and encourage agriculture in this voluntary agricultural district, support protection against nuisance suits, undesired non-farm development and other negative impacts on participating farms.

I/we agree to voluntarily preserve and protect the conservation values of my/our property more completely described on the attachments hereto by prohibiting non-farm use of the property for a period of 10 years from the date of signing of this Agreement, except for the creation of not more than three (3) lots that meet applicable zoning and or subdivision regulations.

This Agreement may be revoked by written notice to the Agricultural Advisory Board, or the Board of Commissioners may revoke the Agreement based on noncompliance by the landowner.

The Randolph County Voluntary Agricultural District Program

Purpose

To promote agricultural and environmental values and general welfare of the county by increasing identity and pride in the agricultural community and its way of life; encourage the economic health of agriculture; and increase protection from non-farm development and other negative impacts on properly managed farms.

Public Benefits

- * Preserves open space in the county.
- * Provides economic diversity in the county.
- * Increases opportunities to produce locally grown agricultural commodities.

Farmer Benefits

- * Informs new landowners of farm presence and potential of dust, noise and smells associated with agriculture, possibly reducing conflicts between neighbors.
- * Requires that farmland be used as a last resort if land is considered for a public project that condemn land.
- * Land enrolled in the program will not be assessed fees or required to connect to water and sewer service if they plan not to use the service.

Who Qualifies

Landowners qualify for inclusion as a Voluntary Agricultural District if they meet the following conditions:

1. The farm property must meet the qualifications outlined in General Statute 105-377.3:

5 acres for horticulture use

10 acres for general agriculture use

20 acres for forestry use

It is preferred that the farm property already be enrolled in the present use taxation program administered by Randolph County however, it is not required

2. The property must have a conservation plan certified by the Natural Resources Conservation Service and/or NC Forest Service.

Stipulations

- * Prohibits non-farm use or development of land for 10 years.
- * Maximum creation of three lots within 10-year period.
- * The property owner may at any time voluntarily revoke agreement by submitting a written notice to the Ag. Advisory Board.
